**FIELD HOCKEY TRAINING, TOURNAMENT, PLAYDAY & LEAGUE  
PARTICIPANT AGREEMENT, RELEASE AND ACKNOWLEDGMENT FORM**

In consideration of the services of Philly Hockey Club, LLC ("PHC"), The Proving Grounds ("TPG"), their officers, agents, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf, I hereby agree to release and discharge PHC and TPG on behalf of myself, my children, my parents, my heirs, assigns, personal representatives and estate as follows:

1. I acknowledge that Field Hockey entails known and anticipated risks which could result in physical or emotional injury, paralysis, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.

The risks include, but are not limited to, colliding with another player or players, walls, or barriers; falling or tripping onto the floor, barrier or other persons; getting hit by a stick, ball, or person.

Furthermore, PHC and TPG employees and volunteers have difficult jobs to perform. They seek safety, but they are not infallible. They might be ignorant of a participant's physical fitness or abilities. They may give inadequate warnings or instructions, and the equipment being used might malfunction.

2. I expressly agree and promise to accept and assume all the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.

3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless PHC and TPG from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of PHC and TPG equipment or facilities, including any such claims which allege negligent acts or omissions of PHC and TPG.

4. Should PHC and TPG or anyone acting on their behalf be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold harmless them for all such fees and costs.

5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I have no medical or physical conditions that could interfere with my safety in this activity, or else I am willing to assume, and bear the costs of all risks that may be created, directly or indirectly, by any condition.

6. All photographs taken at PHC and TPG events are the sole and exclusive property of PHC. I release all claims to their use in field hockey promotional materials.

By signing this document, I acknowledge that if I or anyone else is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit or claim against PHC and TPG on the basis from which I have released them herein.
